CASH FLOW SUPPORT



Has your business struggled to take advantage of a new contract or sales opportunity because of a lack cashflow?

Invoice Finance is designed to provide businesses with the necessary working capital before your customer pays their invoice.

IBA offer access to 60-80% of the value of your buyer's invoice within 24 hours, while waiting for the buyer to pay to enable your business to pay wages, inventory, materials and transport costs.

How it Works

When you receive an order from a buyer, then deliver the products or services and invoice the buyer, you send IBA your invoice or debtors ledger. Rather than waiting for your buyer to pay the invoice, IBA will pay you between 60-80% of the value of the invoice, making the funds available to you. On the due date, the buyer pays the invoice to a bank account managed by the IBA. IBA then applies the funds to your account less any interest and charges.
